NHS England funding for the **Community pharmacy technician: advancing your role programme** has been extended which is excellent news. This is a fully funded course that helps community pharmacy technicians develop their skills and confidence to deliver effective clinical services in community pharmacy. The programme consists of a 4-month self-directed e course, support from an education supervisor, optional peer support sessions, clinical assessment skills (CAS) training and workplace practice of CAS.

Newly qualified pharmacist programme

The provisional dates for the next cohorts are as follows: Applications open in September and cohort 7 starts in November 2024 Applications open in January 2025 and cohort 8 starts in March 2025

Newly qualified pharmacists have described 'lack of confidence', 'decision making', 'managing professional relationships', 'being in charge', and 'adapting to the workplace', as the greatest challenges they face. This programme is flexible and tailored to the learner's needs and career aspirations. It supports pharmacists in demonstrating readiness to enroll on an independent prescribing (IP) training course. The learning takes a blended approach offering a mix of online learning, workshops, assessment and work-based support through a designated CPPE education supervisor.

A reminder that pharmacists registered since 2021 and who are employed or locum in the following settings are eligible to apply:

- Community pharmacy (except Boots)
- Integrated care boards
- Community health services
- Health and justice
- General practice or care homes (except those working in a post funded via the PCN additional roles reimbursement scheme- they need to enrol for PCPEP).

Pharmacists registered before 2021 who are returning from a career break are also eligible to apply.

Primary Care Pharmacy Education Programme (PCPEP) – places for non ARRS funded PCN roles PCPEP is commissioned by NHS England to provide compulsory training for pharmacists and pharmacy technicians whose salaries are being supported with the Additional Role Reimbursement Scheme (ARRS) funding. NHS England has agreed that places remaining for a cohort not taken by pharmacy professionals in ARRS funded roles can be made available to pharmacists and pharmacy technicians in non-PCN roles in GP practices or care homes if their employer agrees to provide the necessary support.

Pharmacists and pharmacy technicians must meet the following criteria:

- Be already working in a patient-facing primary care role for a minimum of about 0.5 wte (18.75 hours per week) in a GP practice or care home setting. Any less than this, the number of days study leave becomes a burden for the practice.
- Have the support of their employer who agrees to:
 - o release the pharmacist or pharmacy technician for 28 days of protected learning time for face-toface events during the pathway, regardless of the number of days per week they are working
 - o provide a GP (or other medic) clinical supervisor for pharmacists OR an experienced pharmacist clinical supervisor for pharmacy technicians. Each pharmacist or pharmacy technician should receive a minimum of one clinical supervision session per month and have access to the clinical supervisor during the course of the working week to address urgent issues. Clinical supervisors would be expected to take part in the CPPE clinical supervisor training (two short online workshops).
 - o ensuring the pharmacy professional's role includes patient-facing work
 - o support the pharmacy professional with travelling expenses for pathway events
 - support the pharmacist through their independent prescribing training at the end of the CPPE pathway (including the supervision required) if they are not already independent prescribers
- Be able to attend face-to-face events, including residential study days over the 18 months and be able to stay overnight for the residential events
- Be able to commit to studying in their own time for up to 30 days during the pathway, as well as attending all the pathway events.

Applications can be made at any time, but they will not be approved until CPPE knows that there are places remaining for the cohort which will be about two weeks before the start of each cohort.
