Pharmacy Advice Audit starting from Monday 3 June 2024.

From **Monday 3 June 2024**, pharmacies are asked to select just **one** day between the **3 and 16 June 2024**, to record data about patients seeking informal advice (outside of the Pharmacy First service). The audit has been designed to be as straightforward as possible, with guidance below: Team Guide – This sets out the criteria for inclusion, what needs to be recorded and how to reflect on your pharmacy's results.

<u>Audit Template</u> – This provides a simple way to record the required data, making things smoother to add data onto your IT platform.

NHSmail multi-factor authentication.

The NHSmail team previously announced that multi – factor authentication (MFA) is set to become mandatory across the platform for all NHSmail users from later in 2024. MFA is an additional security measure that verifies your identity when logging into your account and it will become the default method for accessing NHSmail accounts.

Pharmacy NHSmail users are encouraged to enrol for MFA before it becomes mandatory.
