It is designed to update your knowledge and skills to help you manage common clinical conditions and minor ailments that may present in community pharmacy. The programme contains practical tips and advice on how to identify, recognise and manage over 50 different common conditions.



For each condition, there will be a brief overview of danger symptoms, conditions to consider when carrying out a differential diagnosis, practical tips, special considerations, and comments from a general practitioner (GP) perspective where appropriate.

The content was developed by NHS Education for Scotland. This version of the programme has been adapted by the Centre for Pharmacy Postgraduate Education (CPPE) for use in England.

Care homes: supporting people, optimising medicines e-learning programme

This programme recognises the need for personalised care of people living in a care home setting and aims to support you in working with the multidisciplinary health and social care team to apply a person-centred approach to delivering medicines optimisation in care homes.



This updated e-learning programme, and accompanying e-assessment, aims to equip you with the skills and knowledge to apply the principles of personalised care during structured medication reviews in line with relevant standards and legislation relating to care homes.

At the beginning of May 2024, NHS England agreed that places remaining for a cohort not taken by pharmacy professionals in ARRS funded roles could be made available to pharmacists and pharmacy technicians in non-PCN roles in GP practices or care homes, if their employer agrees to provide the necessary support. **This applies to Cohort 17, starting September 2024**. Employers must agree to provide the necessary support for pharmacy professionals to fully participate in the programme.

Applications can be made at any time, but they will not be approved until CPPE knows that there are places remaining for the cohort which will be about two weeks before the start of each cohort.

Chief Pharmaceutical Officer's Pharmacy Leaders development programme

Applications for cohort 7 are now open and will close Monday 16 September 2024. NHS England and CPPE held a webinar 26 March 2024 to promote the programme and provide further information. A key objective of the programme is for delegates to make a positive contribution to improving the diversity of those in senior pharmacy leadership positions in the NHS. We aim to make each cohort broadly representative of the pharmacy professions' registers with regard to gender, ethnicity and profession. We particularly welcome applications from pharmacy leaders from a Black or minority ethnic background and pharmacy technicians working in senior roles in NHS trusts, PCNs, and community pharmacy.
