#### **Online workshops**

New from November <u>Valproate: the hard conversations</u> - focal point - People taking valproate have told us that they want to have conversations with pharmacy professionals about valproate. We are often the most approachable and readily available point of contact for them. However, these same people have told us that pharmacy professionals can be reluctant to engage with them.

This workshop will support you to engage with people taking valproate. It has been developed using lived experience scenarios and will explore the following questions:

- What is the role of pharmacy professionals in managing valproate risk? •
- What are the specific risks of taking valproate in pregnancy? Out of 100 babies exposed to valproate in pregnancy, how many of these will be born with a major birth defect or developmental disorder?
- Can you convey this information to a person and signpost them effectively using a person-centred • approach to care?

• Introduction to overprescribing

The aim of this learning programme is to support you to identify overprescribing in your own area of practice and help you empower people to be more involved in decisions about their care.



New - A new website page has been launched for Consultation skills for pharmacy practice



The website is the new home for the Medicines Related Consultation Assessment Tool (MR-CAT), a tool that can be used in any area of practice and has been developed by CPPE. On the website there is e-learning on how to use the MR-CAT for direct observation of practice and as a self-assessment tool. The e-learning includes videos of two consultations and pharmacy professionals assess these using the MR-CAT and then there is a sample answer. This supports pharmacy professionals to conceptualise what good consultation skills practice looks like and gives assessors confidence in assessment decisions. #### Community pharmacy technician: advancing your role: CPPE.

Our funding for this programme has been extended to March 2025 for 80 places. This programme is also open to pharmacy technicians working in the Health and Justice sector.

#### Accuracy checking pharmacy technician programme (ACPT)

From 1<sup>st</sup> August 2024, NHS England has funded CPPE to offer the ACPT programme for pharmacy technicians working in community pharmacy, NHS hospitals, and in Health and Justice. A total of 80 NHS-funded places are available, with 10 places on the course each month. NHS England funding for places on the ACPT programme will end when all 80 places have been allocated or by the end of March 2025. 50% of the funding has been allocated for community pharmacy and 50% for other sectors.

The ACPT programme is open to pharmacy technicians who are registered with the General Pharmaceutical Council (GPhC), work in premises in England and who meet the entry criteria. You can check the entry criteria <u>here</u>.

#### Newly qualified pharmacist programme (NewQual)

Funding has been confirmed for additional cohorts of the Newly qualified pharmacist programme. Applications for the November cohort are still open and will close on 30th November.

This programme is designed to focus on the career aspirations and learning needs of newly qualified pharmacists. Education supervisors work closely with pharmacists to identify development needs and career aspirations, creating a personalised learning pathway. Whether pharmacists are looking to change their area of practice, become Independent Prescribers, or take on leadership or managerial roles, the programme is tailored to support their goals.

#### Primary Care Pharmacy Education Pathway (PCPEP) update

The latest cohort 17 began in September 2024 with 250 pharmacists and 110 pharmacy technicians. Since May 2024, we have been able to offer any remaining places to non-PCN pharmacy professionals working in GP practice or care home roles after all the PCN funded pharmacy professionals have applied. We are expecting there to be places remaining in the January cohort so, if you have pharmacy professionals who are not funded using the PCN ARRS funding please consider encouraging them to apply.

In addition to the nearly 7000 pharmacy professionals who have completed one or more of our pathways over the last 8 years, we have another 600 plus learners due to complete in the next few months.

Other updates covered in the newsletter include details of Health Innovation West Midlands Virtual Polypharmacy Workshop, RPS advanced practice pilot, plagiarism of PCPEP assessments.
